LIQUOR AUTHORITY

As per the *Western Cape Liquor Regulations, 2011: Amendment, 2022* the following licensing fees are effective as of **1 December 2022**, except for the section 64(1) renewal application fee which is effective as of **22 July 2022**.

Granting fees are only payable upon approval of an application and as communicated formally by the WCLA.
